PUBLIC FORUM

Agenda Item 5

There were nine (9) members of the public present for the meeting.

<u>Freedom campers</u>

- A resident from James Street was present at the meeting to discuss Freedom Campers and the bad experience the street had over the summer. It was noted that Freedom Camper numbers had doubled over the summer and that some residents reported campers stealing vegetables from their gardens and water from their outside taps. The residents had also witnessed arguing amongst the campers. The resident noted that they unfortunately missed the consultation period when it was open.
- The resident requested the Raglan Community Board (RCB) take this issue to the Waikato District Council, and advise them that the consultation didn't go well, and suggested that Council look at long term solutions for Freedom Campers like toilets, skipbins and water.
- It was noted that 80% of the campers were not within walking distance of a toilet.
- A query was raised in relation to the Jane Street residents speaking directly to the campers about the issues. In response, it was noted that no residents had spoken to the campers directly.
- A query was raised in relation to a submission that RCB put forward, it was noted that the board submitted a response to central government via the consultation process with a number of recommendations.
- Discussion ensued and some of the key topics considered including, enforcing and monitoring regulations, engagement with campers, reimplementing a freedom camper ambassador and platforms for sharing freedom camper spots.

• Confirmation was sought and received in relation to bylaw review timeframes and it was noted the Freedom Camper review was due 20 November 2028.

Bus update

- A resident was present at the meeting to request an update on bus services. It was noted that another township (Cambridge) had approximately 20 buses running and inquiries were made as to what the Raglan Community Board could do to get more bus services implemented and rolled out.
- It was noted that an increase in the frequency of service encourages higher patronage which enables a commuter status.
- Confirmation was sought and received on the submission process for the Waikato Regional Council's (WRC) Public Transport Strategy – WRC will take over the services in its entirety.

Swimming pool at Rangatahi

 A resident was present at the meeting to request an update on the Ranagatahi Swimming Pool Project. It was noted that the Raglan Community Board had provided a letter of support to the project, with the proviso that in regard to construction and maintenance, there was no cost to the ratepayers.

REPORTS

Xtreme Zero Waste - Te Uku Project Agenda Item 6.1

The report was received [RCB2405/02 refers] and the Council's Waste Services Manager together with representatives from Xtreme Zero Waste were present at the meeting the following discussion was held:

- Volume of waste: a survey was conducted over eight days, no persons were arriving during the daytime when manned, however, people were turning up and illegally dumping waste over night.
- Additional plastic and cardboard cages along with bottle lid containers had been installed, along with a hoop lid and scrim fence to stop loose litter flying into the stream/school.
- The Collections Manager provided some figures on street bins/bags pre/post covid and tonnage in landfill, it was noted there is a 50% increase over the summer months.
- Discussion ensued with some of the key topics considered including illegal dumping, location of users, type of rubbish being dumped, cost of items being illegally dumped and contracting of street bins.
- The Waste Services Manager tabled a document and provided an overview of the cost of services and a breakdown of the area serviced, contract management and current processes and new initiatives. She noted there were plans to build a resource recovery center, however, planning/budgeting was in the early stages.

- Discussion ensued with some of the key topics considered including central government's container return scheme, emphasis on business owners to install bins outside premises, Te Uke processing versus Te Mata processing, and potential new concepts such as leasing land from farmers.
- The Chairperson thanked the representatives from Xtreme Zero Waste for taking the time to present at the meeting.

ACTION: Waste Services Manager together with Zero Xtreme Waste to create a graph of the location of users by day and provide to the board.

<u>Discretionary Fund Report</u> Agenda Item 6.2

The report was received [RCB2405/02 refers] and it was noted the board's preference was to defer the resolution until the next meeting and attempt to contact Raglan Lions Club one more time to ascertain if the invoice still required payment or obtain written confirmation they no longer required funds. If no confirmation was received, the board would resolve to put the money back into the discretionary fund.

<u>Discretionary Fund Applications</u> Agenda Item 6.3

The report was received [RCB 2405/02 refers] the following discussion was held:

Ruapuke Beach Care Group - pest control/native plants

- A representative from the group noted that the pest control measures together with the native plants would help ensure native birds and other wildlife such as lizards would thrive in the area, and that cameras would help with tracking the wildlife.
- A query was sought in relation to other funding sources, it was noted the group had not applied to other funding sources yet. It was noted that the group could fundraise from other areas eg Regional Council and Meridian.
- A brief overview of the purpose and use of the cameras, data collection and trap placement was provided.
- Discussion ensued with some of the key topics considered including erosion planting, previous funding, direction of applicants (part of the funding solution) and what equipment was a necessity.



Kia ora Lianne

My name is Betty Diprose. I'm the guidance counsellor at Raglan Area School. One of my roles at kura is to work with young people who have been identified as being mentally and emotionally at risk and/or who see themselves as socially not fitting in with other mainstream students. This may be due to neuro or gender diversity, family trauma or other factors that place these students on our 'at-risk' radar. One of the programmes I have been trialling over the last year is running a Dungeons and Dragons group for these students in the Year 9-11 age group. This is a table top venture role playing game that seems to work really well with this cohort of rangatahi.

The game is run by a DM (Dragon Master) who presides over the game, creating imagination based 'campaigns', applying rules and consequences for decisions the players make and generally keeping things safe for participants. It's in this safe social space that young people can make positive connections with other like minded young people, practise social skills such as respectful communication and managing feelings along with wonderful opportunities for creative thinking, peer mentoring and leadership. The DM we have had in the past is teacher trained and has a particular skill in customising the game to further enable specific social skills to be practised in the role-playing context. A couple of the students who have been involved in the programme over the last year are also getting close to being able to take on the role of the DM but for this to happen the students need another term or so of being mentored by the experienced DM.

There is a cost involved in accessing this DM. Last year we were able to access funds through the DHB's Community Suicide Postvention Response Service. Due to that funding no longer being available this year, families are fronting up with the main cost and the kura is also making a contribution, however, there is still a shortfall - mainly to do with the DM's transport costs (he travels to and from Hamilton).

We would appreciate your consideration in supporting this initiative financially. A contribution of \$500.00 would enable the programme to run over term two. A contribution of \$1000.00 would get us to the end of term three. This would be enough time for our DM trainee students to be further mentored by the DM, with the goal of them taking over leading the group thereon.

Raglan Wharf Structural Repairs, Pontoons and Walkways

All work is now complete with the opening ceremony held on Friday 3 May 2024.

Sea Wall repairs were completed in November. Arborist work has been completed to remove several low hanging branches. Watercare have also completed the replacement of the watermain feeding across to Papahua.

Contractors have now completed installing scaffolding to allow for footpath preparation to be undertaken safely. Existing footpath has been excavated and removed from site. Earthworks in preparation for concrete pours are underway. The 2.8m footpath and balustrade will complete by the end of July 2024.

Here is a short analysis of data detailing weekend survey responses for the Te Uku Depot detailing WEEKEND ONLY DATA.

- 1. 76.4% local use.
- 2. 85.2% local and people on their way to Hamilton.
- 3. 6.1% Auckland and 'other'.
- 4. 14.1% of people were going to an "out-of-rated area". (Ngarūāwahia, AKL, Kirikiriroa/Hamilton).
- 5. 15.8% are from Raglan that has kerbside service and access to the manned site at Te Hutewai Road.
- 6. 8.7% Outlier behaviour (x3 assumed back to Raglan noted as suspicious behaviour, and 1x Te Akau, 1xTe Uku, x2 preferred not to say).

This generates findings that suggest 93.9% of usage is by locals near to the depot and at the very least within Waikato.

With only 3.5% being 'Aucklanders' and a subsequent 2.6% as assumed out of district 'vacation'.





Sometimes the bins are overflowing. (I also saw the lady climb up onto the tray to get her tin cans into the slot - didn't look very safe, not particularly friendly for short people)

Fantastic service but not emptied enough. Sometimes we have to take our rubbish back home because there's no space for it. Once it gets a bit messy people just seem to dump stuff everywhere. There should be surveillance cameras around

It's never this tidy, it's always a tip! Everyone just dumps and drives away. Fees like a clean up has happened because we have arrived to do the survey. Normally only 2 bins for blue bags, not 3.

We only drop our rubbish off when we can see it's tidy, we often come and take stuff back because it's overflowing. It's usually much messier than it is today, it reaches to the edge of the tent. It's not emptied nearly enough. The cardboard is the worst. Large household items are left here for ages, only collected when I've called to complain. The rubbish gets blown over to the creek and our farm. Lots of black bags are put in the prepaid bags box. Rubbish flys down the road, I've asked many times for better fencing to be put in to contain mess. As neighbours we are very disgruntled, it's not fit for purpose. My suggestion is to put a camera up. It's too expensive to take stuff to xtreme waste so people dump it here.

It's usually a real mess, a horrible place to have to come. It's too small to service the area.

Sat 25th November 23

Feel sorry for the people cleaning it up.

It's always a mess

A lot of commercial rubbish being dumped here. From out of town. He's sees cars that are sign written dropping commercial waste

Should have a camera here. People need to be caught.

Glad it's here so doesn't have to go to extreme it's a great lay out. Just always a tip It's looking a damn sight better. It's a pleasure to come on the weekend now, before I've avoided it on the weekend

We surveyed this lady yesterday and she wasn't keen to do the survey again

People are the problem. Making it a dumping ground. Not local people, main road people.

It's great to have somewhere local.

Having a gate with a tag for locals.

There are like 15 new houses within a km of this rubbish sight. So many more people in te uku using this facility. There needs to be more funding to clean it.

It's so much cleaner on a Saturday than it's ever been.

Need to get something for our rates.

Have blue bags at the te mata station.

People are abusing it

We would be lost without it.

Only that other people are "shits", people treat it like a dump and leave their crap everywhere.

We only bring our recycling because our landfill is picked up

Nah it's allgood

It's awesome, it gets packed though. Would be good to have another plastics bin and cardboard because they get filled the fastest then it's overflowing and crap goes flying everywhere.

Coming to collect egg cartoons.

Have been told collections are on Wednesday and Friday so they come before collections to find egg cartoons

They said it's never been employed as frequently since we have arrived

Come home from night shift and there are dogs up here playing.

Short of picking them up from our houses which don't work, they expected us to maintain a townie policy overnight - leave on road people will hit it and milk cows at 5am and rubbish all down the road and roads not wide. Leave by the gate and they drive past it.

Bunch of lazy bastards.

Dogs found it.

Didn't work.

This emptied more often and we won't get the overflow

We are getting fly tippers

It looks really great here today - much better than it normally does for a Saturday
They need a larger plastic bin, surveillance would be good and stop people dumping
crap. The landfill bins are good and enough but need at least another plastics bin
It's looking tidy today but isn't always. The plastics bin is often full then people just
dump their stuff on the ground next to it

I often don't bring recycling cause I know that it will be full. Can we have double plastic space, maybe combine tins and aluminum and make plastics twice the size

Somewhere to put lids from plastics incase you've forgotten to take them off and put in a blue bag. The bins are hard to reach for short people. The trays fill up with water so would be good if they had holes to drain. The upgrades have been great, it's much better than it was. It's annoying when people dump stuff they shouldn't. The shade is annoying in high winds it's flying all around.

It's good compared to what it was. It's a shame that people are abusing it like they are. It's been tidier the week the survey people have been here. We've seen builders dump stuff. The plastics is overflow quickly

And bins at te mata (landfill)

Te Mata recycling is really messey - scared of popping your tyre

Windy day rubbish flies everywhere

Going into our water and streams and onto the road and can be hazardous.

In te mata we need more cardboard caddies

More plastics and cardboard spaces needed as they fill up the most, way better than it was before though. Lids need their own containers as they end up all over the floor!!

Much tidier since you have been here. Plastics and cardboard get the fullest

Normally it's chocker

My son used to clear it - it has got better and concrete great and it looks good today but it's normally really messy

People are going to come and dump stuff.

Plastic lids and we take them off and put them in.

People bring stuff that they shouldn't but the do.

We dont get picked up on the main road.

People are the problem.

Only way to catch them is go through it and find names on rubbish.

People that have stayed at raglan are dumping here.

Before we had double on each side and now there is only one.

Not as big as when we had it before double and double.

Shelter is great.

This is probably the cleanest I've seen it.

If there were maybe a camera here it would be interesting to see that if people changed.

Our kids know what goes on at the recycling centre - behaviour it's about behaviour.

We have celebrating our TOP recycling here in Raglan people need to now about that.

We dont want to go to raglan to do our recycling we want this place we want to keep it.

We tidy this place up we like it we want to have it nice our kids went to school here

Na

Wasn't going to leave cardboard because it was over flowing.

Most of the time it's fantastic.

Sometimes over flowing.

Plastics always over flowing.

Please empty more.

Only comes on a Saturday morning at 6am because it's to full on a Sunday but came today because he was at a party last night and someone said that extreme are emptying it everyday now. And that there are people working here to monitor it.

The plastics doesn't work - overflows.

It's good for rural people.

I use incinerator at home for paper and cardboard.

I bring my plastics in these bags because it's always full so I leave them here like this so it won't all fly away

Always notice plastic overflowing. Everyday! Could do with more storage for plastic

It would be lovely if it wasn't overflowing. It's regularly overflowing.

I do appreciate it.

It's great that I don't have to go all the way over to Xtreme Zero Waste.

N/A

We need to keep it for the community. More education is needed, like signage, to show people how to use it. Like telling them to wash and squash, to take off lids ect. I come down and clean up here sometimes because it's such a mess and I feel bad for the guys coming to collect it all. The holes for recycling can be hard to reach for us short people.

People badly abuse this place. I know the rubbish bags are expensive but it needs to be treated with respect

It gets full quickly

It's great, I would love to have the food bins they have in town. It does get a bit manky here sometimes

Love to see blue bag collection at Te Mata. The community feels a bit hard done by that Waitetuna gets theirs collected and we don't even have a bin to drop ours into.

It used to be a shit hole and now it's not such a bad shit hole.

Xtreme Zero Waste is the worst run company I have ever known.

Haven't been here for a year.

Sometimes it's overflowing. Would be good to have land fill pick up at Te Mata

Already did the survey, not keen to do it again

It's good, sometimes it can be a real mess

All ready been surveyed, no new comments

It's pretty handy to have

It's great, would be good if it was twice the size as it fills up so quickly

The guy did a quick dump and run of a metal "thingamabob" maybe a car accessory(?) into the prepaid bag bin

Needs emptying more often, but we know extreme do a great job people do a lot of dropping of random things and they should take responsibility themselves

We really love this facility and use it to drop recycling and landfill on way home from family bach often as we can't leave things out for kerbside as we are not here in the week. We know many other families who use it this way also

I like the facility but I definitely think they need to do more collections. Not having rubbish facility in te mata is a real hassle

Marae said to drop recycling here

Sometimes I have to turn around because it's so full there's no space. It's great that it's covered now. It's great that it's here, much more conviennent than going to xtreme.

Needs to be emptied more often. The trays are handy

I was here at 5:30am dropping off my recycling and saw a guy dropping off his black bags

It's great. It's annoying that some people just dump their non recyclables, maybe security cameras would help with that

No my husband usually does the recycling. Seems nice

Needs more collections, always overflowing, mainly plastics and cardboards. Glass and tin, skip bin are always ok.

Would love a kerbside collection okete road, bridal creek road.

They don't service it enough. They clearly don't do it when they say they will.

I use this as a drop off on my way home to te uku after cleaning air bnbs

Xtreme are bloody useless.

When this was put up it felt like a really good idea. Needs at least one extra clearance per week.

Xtreme don't put in as much time as they need to.

When it's like this I don't want to leave the stuff. I will have to come back another time

Forklift could lift dedicated containers to make it easier for the collection team.

They need one more massive plastic containers

This is definitely so much nicer than I have ever seen it before. In the history of the te uku rubbish.

We come out from Waitetuna to do recycling, often is overflowing, normally can't fit our recycling into here on the weekend. Feel bad to just add our plastics and recycling into everyone else. It's obvious it needs clearing more often!!

Dropping recycling from family wedding

Been into Hamilton for the day and dropping rubbish from home on way back home to te mata, dropped black bag same as other day.
