Meremere Works & Issues Report September 2022 Agenda Item 5.1

The following items were discussed:

- Cr Sedgwick presented this report as Merv was not present. Skatepark developments are almost complete, an opening is planned for end of September with the Puna, the school and the local skate club.
- Asked if the council has received the reports for the repairs needed in the hall, Cr Sedgwick not sure but Okeroa said a report has been made with a list of all the repairs needed.

Councillor's Report Agenda Item 5.2

Cr Sedgwick gave a verbal report on the following matters:

- Local alcohol draft policy is seeking submissions, there is a current cap of how many independent liquor stores allowed in the area, this is part of what's being reviewed, forms are at the library or can be done online, submissions close 11 of September.
- Cr Sedgwick's last meeting, there are two (2) councillors running at the moment, Marlene Raumati who lives in Te Kauwhata and Tremain Thompson who lives in Auckland
- Mayor Allan was retiring and there were four (4) candidates running for mayor, there is also a candidate evening at St Margaret's Church on 14th of September at 7pm

- Mayor Allan shared some stories of his 12 years as Mayor and expressed his gratitude to our committee. He discussed some of the legacy he is leaving behind and the positive impact he has had on the region.
- We stopped the meeting to have a cup of tea and shared food, the committee presented Cr Sedgwick with a leaving gift
- Received an update on the Paa site- demolition of the water tank to start 5th of September and will be complete the 12th of September, demolition being done by Apex with the help of Nikau. Darren Wright is the site manager, the next stage after demolition will be whanau/community consultation to create a final design plan for the paa site, an archaeologist report has been sent to the Chair.
- Also received an updated on the land at Te Paina being returned to mana whenua, the land was reserve status, so it had been a process for the hapu to change that. October is when the outcome would be known, Haydn also thanked Mayor Allan for the legacy he has left behind. Council members left at 8.12pm

GENERAL BUSINESS

The following items were discussed:

- Marisa and Myles spoke to the committee about starting a fast five tournament here in Meremere in the hall, netball hoops and the courts to be marked out are what's needed for that to happen. Fast five for adults and soccer for kids, registration from adult fast five teams will cover costs for kids' sports. A food stall can be set up for fundraising from the hall kitchen on those nights, money raised can go towards upgrading facilities or buying things for all the sports. There's potential for a summer league of netball, touch, badminton, soccer, t ball, softball, so a sports coordinator is needed and a committee to facilitate the sports for Meremere, they have 3 volunteers at the moment. Advised by James to gather costs and make a proposal to the development committee and they will apply to Sport Waikato for some start up funds. Cecelia advised them to attend a hall meeting as well as they are the managers of the hall and they have procedures in place that will need sign off before a tournament can start.
- Ben recently met with AI security to update the cameras at the foodbank, he is waiting to receive a quote for a new system with an increased pixel rate so it's a higher quality image.

- Cecilia said Pukekohe probation had been in contact with her to supervise PD boys, she volunteered once but does not want to commit every Sunday from 9 to 3pm, The Chair advised her to tell them she doesn't want to do it.
- Hall committee AGM is on the 2nd of November 2022 7pm, they have three (3) current members and welcome nominations
- Melysa asked if the committee would be open to commit \$1000 towards a new Meremere school sign, the committee asked for photos or a quote to make a serious consideration.
- Discussion was had over the school needing a van, Cecilia and James expressed that a community van is needed more, the school only has a role of 14 so a school van only serves a small section of the community.
