- Dog park project
 - Tim Hinton advised that the poles for the shade cloth have been delivered and installed and that the necessary paperwork will be submitted to Council.

- It is anticipated that the shade cloth will be installed in the final quarter of 2024.

- The small dog exercise area and the double gates will be installed thereafter.
- Saleyard Road Walkway project
 - John Cunningham advised the Committee that Ed McVicar is liaising with KiwiRail regarding access to the walkway. A permit may be required.
- Community Identity project
 - The updated project action list and dates were noted.
 - Liz Tupuhi informed the Committee that 163 responses were received from the survey and that most of the feedback related to the history of the township.
 - Estelle Jonathan advised that a prioritization of activities will need to be undertaken by the project team. John Cunningham indicated that this can be circulated via email to the Committee since the next meeting is in August 2024.
- Te Kauwhata Domain
 - Tim Hinton advised that as part of the completion of Stage 1 some fencing has been installed for safety reasons. A gate has also been installed (locks to follow).
 - Planting to be done below the Rugby Club where the land drops to the houses on the other side
 - It was noted that Stage 2 of this project is dependent on funding being made available through the Council's 2025-2034 Long Term Plan.
- Security cameras
 - It was noted that the project goal should be changed from the reference to the car park and freedom camping area to the cameras providing security for the township in general.
 - It was noted that staff have done the first draft of a Memorandum of Understanding with Hamilton City Council and that this was now being considered by an internal steering group of WDC.
 - Cr Raumati advised that the cost to the Council for the camera rollout is significant and that this was being deliberated through the Enhanced Annual Plan.

- Rongoa Garden project
 - Estelle Jonathan advised that the next site meeting is 10am on 21 June 2024 when the first planting of the manuka trees will take place. The manuka trees will act as windbreakers. The kahikatea will be planted later.
 - The location of pou will be determined by mana whenua.
 - Liz Tupuhi shared a map showing the indicative location of the garden. The map will be included in the works and issues report.



Project Summary

The Project Team would like to emphasise the purpose of this project which is to develop a strategy towards an aspirational future for Te Kauwhata and Districts. While there is consensus on the Project Team that the Strategy will be informed by two central pillars – our unique environmental and historic sites and stories – we believe it is paramount that our communities and stakeholders have a real opportunity to contribute to this vision and shape the short, medium and long term projects and goals that will be written into the Strategy as steps towards the vision. We cannot preempt these projects and goals. As such the next steps for our team are:

- 1) To develop a visual tool to introduce the project to the public and stakeholders. Our preference was originally to commission a high end video that showcases those important features pertaining to our central pillars. This has been costed and will require a budget of \$10,000+GST via Nimbus Media, or there is a possibility of a collaboration with Ngaa Muka who are also creating some new media over the coming months. If the budget is not available our Plan B is to create our own visual slide show which Lauren Hughes has volunteered to coordinate.
- 2) Plan and carry out a round of consultation that will take place between Mar-May 2024. The stakeholder groups we have identified for the first round of consultation are as follows. We welcome the Community Committee's addition of anyone we may have neglected:
 - Te Kauwhata Community Committee
 - Meremere Community Committee as courtesy
 - Ngaa Muka
 - Rangiriri Paa
 - Schools in the defined area
 - Businesses in the defined area
 - Community organisations in the defined area
 - Aparangi
 - The general public

We expect that the projects and goals raised in this round of consultation will fall into these key areas:

- IDENTIFY what are those important features under our pillars?
- CONNECT what infrastructure do we need to connect them eg walkways, cycle ways, roads, maps, websites
- ACCESS how else can we create access for the public to enjoy these sites? Tourism businesses, accommodation, disability access, public events, media, online resources, educational resources
- PROTECT & DEVELOP if we want to be proud of these sites what are our responsibilities to them and what regulations do we need to advocate for to ensure that others working, living, visiting, doing business in the area cares for them too.
- CELEBRATE how do we keep stakeholders and the community united around our identity and this vision for the next 50 yrs? How do we celebrate each milestone along the way?

We have updated the Project Plan below and you will see there is a second and third round of consultation planned. The second round is for specific people or

groups who will be directly impacted by projects and goals that may fall out of the Strategy. For example if the public tell us that they want a walkway to connect site A to site B we will then have a specific set of stakeholders to consult around that project including landowners, neighbours, kaitiaki of the historic or ecological sites etc.

The third round of consultation will come after our Draft Strategy has been drawn up and it will include all those we have consulted with previously. At this point we will just be seeking to refine the Draft Plan and ensure we have not misrepresented any of our stakeholders.

Project Summary

- A subcommittee drawn from Te Kauwhata Community Committee members and invited stakeholders has formed and meets regularly towards the development of an Identity Strategy. The purpose of the Strategy is to articulate those things that make our region unique and create a tool for planning and advocacy that will focus future investment and development in Te Kauwhata and Districts in such a way that connects, protects, and celebrates those central pillars:
 - o Our unique environment (wetlands, waterways, and associated wildlife)
 - Our unique culture and history (Rangiriri pa and other sites and stories of historic significance)
- The Strategy will be a guiding document stating a 50-year vision and the associated social, economic, environmental, and cultural outcomes sought for Te Kauwhata over the next 50 years. It will also include the short, medium and long-term projects and goals required to achieve that vision.
- The Strategy will broadly cover the geographic area between the five Nga Muka marae Hora Hora, Maurea, Waikare, Taniwha and Okaerea. There is an acknowledgement that this is a soft border and important environmental and cultural features such as the Whangamarino Wetlands and the connection between Rangiriri and Meremere may require a flexible, inclusive approach.
- The Strategy will record aspirational, community-led, long-term goals for our region that will be used to:
 - Advocate and inform the planning of other stakeholders in our region including local and regional council.
 - Identify and drive key projects that will realise the goals of the Strategy and cement the Identity of the region internally and nationally.
 - Provide a strategic focus for the development of other community-led amenities.
- Prior to drafting the strategy, the Project Team will lead community and stakeholder consultation. The council has contracted an external agency "Interactionz" to facilitate the

community engagement, while Kāinga Ora is funding and organising the Community Day and Community workshop as part of the community Consultation Process.

- The project team will collate the community contributions, drawing out common themes and ideas to progress further with relevant stakeholders. Once the direction and goals are identified, the team will write or commission the writing of the draft Strategy.
- The draft strategy will be taken back to the community for feedback before a final Strategy is produced.
- The final Strategy will include mechanisms for how it will be implemented, monitored, and used. The Project Team will continue to take a key role in these matters and update this document to detail Phase 2 at the proper time.




The development of a walking/cycling network in and around Te Kauwhata creates an opportunity to connect to a wider regional cycling and walking network.

1. Purpose of the report Te Take moo te puurongo

To seek approval from the Te Kauwhata Community Committee to adopt its Community Committee Plan 2024-2026. The Community Committee Plan outlines the goals and aspirations that it has determined under each of the four well-beings; economic, social, environmental and cultural - for the next two years.

2. Executive summary Whakaraapopototanga matua

In June 2023, Her Worship the Mayor invited Community Board and Committee members to meet with her and Councillors to workshop how the partnership with Council could be improved and strengthened, to drive better outcomes for communities.

Follow-up meetings between Board and Committee members with Council Managers from Democracy and Economic and Community Led Development agreed that Boards and Committees would focus on leadership on the 4 Wellbeing's, Economic, Social, Cultural and Environmental.

In November 2023, a dedicated Council staff resource to this work programme was identified and has been working closely with members of Boards and Committees to develop their framework and future work programme of focus.

As a result, a number of hui have been held with the Community Committee to identify and establish its direction and priorities for the next 2-years. To this end, it has developed a plan for a 2-year period that outlines its goals and aspirations that it is wanting to achieve under each of the 4 well-beings including goals around engagement.

3. Staff recommendations Tuutohu-aa-kaimahi

THAT the Te Kauwhata Community Committee approves its Community Committee Plan 2024-2026 for adoption.

4. Background/Discussion Koorero whaimaarama/Matapaki

The Community Led Development Advisor role works primarily with the Boards and Committees on the following:

- Building capability and capacity with Members to strengthen the three-way partnership with Council, Boards and Committees and the Community.
- Create a Community Board/Community Committee Plan that sets out the goals and objectives that they want to achieve during their term in office.
- Training and working alongside the Boards and Committees to achieve their goals and priorities.
- A strong focus on relationship building and engagement with partners and internal stakeholders to showcase the value-add proposition that Boards and Committees have.

Since November 2023, work has commenced with each of the Community Boards and Community Committees to build their capability around the four wellbeings. As a starting point, a framework was developed in collaboration with Community Board and Community Committee representatives for their Plans. This was then presented by the Members to an end-of-year celebration held by the Mayoral office in December 2023.

Work is well underway and the 10 Boards and Committees on building the content of the Plans and highlighting what it is that the members want to achieve during their term of office underneath each of the four wellbeings. The koorero to date has been met with enthusiasm and a desire to really lift the level of conversation away from "Works and Issues" reporting toward discussion around growth and investment, cultural values, protection of our natural heritage and creating the social infrastructure for our people.

5. Next Steps Ahu whakamua

Once adopted, the next phase includes the creation of an implementation plan where the Community Led Development Advisor will hold hui with the Community Committee to decide key focus areas over the next 6-12 months. In parallel to the implementation plan, work will commence on a 'Plan on a page' for the Community Committee to showcase its individual brand and its key priorities to the community.

A message from your Community Committee

The Te Kauwhata Community Committee is elected every 3 years by the people of Te Kauwhata. The next election is November 2025.

Currently, there are 10 voluntary members who meet monthly on the first Wednesday of the month in the Ambulance rooms in Baird Road.

Our aims are to:

- listen to the community.
- Promote and advocate for projects that will enhance Te Kauwhata.
- Work with our Councillors and community to give feedback to Council.

We work with Ngā Muka Development Trust, the Te Kauwhata Events Committee, the Te Kauwhata Community House, sports clubs, the A&P Show Committee, and other organisations to help build a cohesive development of Te Kauwhata. This ties back to the four wellbeings that we follow - economic, social, environmental, cultural.

Te Kauwhata is a fast growing area in the Waikato, and over the next decade will see changes that will enhance the village economically, socially, environmentally, and culturally.

1. Purpose of the report Te Take moo te puurongo

To seek a recommendation from the Te Kauwhata Community Committee on the Proposed Road name under SUB 0340/18 Lakeside developments, Te Kauwhata.

2. Executive summary Whakaraapopototanga matua

This report requests that the Te Kauwhata Community Committee approve the attached proposed road name for this subdivision at Lakeside, Te Kauwhata. The road name "Te Pehinga Street" has been proposed by local hapuu Nga Muka Development Trust and the developer, Lakeside Developments Ltd.

The names have been checked by Council staff against the Road Naming Policy.

3. Staff recommendations Tuutohu-aa-kaimahi

THAT the Te Kauwhata Community Committee recommend to the Infrastructure Committee the following proposed road name submitted by the developer for SUB 0340/18 Lakeside developments Kauwhata:

- a) Road 1 Te Pehinga Street
- 4. Background Koorero whaimaarama

The Lakeside development (SUB 0340/18) is a fast-growing residential development located on the banks of Lake Waikare and on the fringes of the Te Kauwhata township. Lakeside will accommodate a total 1,659 new homes along

with a future primary school and commercial precinct. There is also over 50 hectares of planned open green space, neighbourhood parks and wetlands and over 5 kilometres of walking and cycling trails.

While a pre-approved list of names exists for the Lakeside Development, the developer is permitted to go outside of this list and propose different names. This is contemplated in the Road Naming Policy under section 1.2 as follows:

1.2 Request for Road Name not from the "Approved List" of Road Names (a) Where an "Approved List" is not available or the subdivision developer wishes to choose their own road names, the developer shall make a request to Council's Roading Asset Team.

Through the developer's consultation with Nga Muka, one name was proposed for the road and agreed upon by both parties as they relate to the history and acknowledge the wai (waters) surrounding and running below and through the whenua (land).

Staff have reviewed the name and considered it does not duplicate, sound too similar, or is a duplicated street type (e.g., street, road, avenue, boulevard, junction, crescent, etc) which may otherwise cause travel uncertainties in the Waikato District. The name has also been checked against Google mapping and NZ Post.



brief history

Nga Muka Development Trust is a collective of the Waikato Tainui marae in the Rangiriri, Te Kauwhata Waerenga Waiterimu arena.

In recent years Nga Muka has concentrated on ensuring that the new street naming included names of historical significance to Mana Whenua of the area. Most of the district rural roads surrounding Te Kauwhata are named after settler families. Up and until Nga Muka formed a positive and proactive relationship with Lakeside Developments Ltd the street names on the new subdivisions from Pokena to Te Kauwhata were being populated with post contact settler historical figures and relevance with the exception of Rongopai street which whllst having a deep meaning in Maori was applied because of Rongopai Wines as part of the viticulture history

This pattern of street naming that preserved and accentuated post contact European history is a feature across the WDC region.

Apologies for the delay in response.

After conducting our research, we have gathered pertinent details regarding the names "**Miriama and Merehira**," which were among the 34 names submitted for approval by the INF committee back in March 2022. It received approval under resolution number INF2203/04. **Te Pehinga Street** is not on the pre-approved list.

As per the existing policy, there is no mandate that necessitates the use of the pre-approved list for naming purposes. Developers have the option to propose their own names after consulting with and obtaining approval from the Local Iwi.

From a process point of view the focus should be on suggesting a new name, **Te Pehinga St** outside the list for allocation to the specific road, noting that the wish is to replace an existing named road.

Please follow the road naming process as provided for the Councils website and download the Road Naming Application form.
