
Who are we?



We are the WDC CAAST Team (Climate Action, Adaptation and Sustainability).

Our work involves sustainability and climate action, climate risk, adaptation, education and resilience within council and in the community.

Our changing climate



- The number of climate-related disasters has tripled in the last 30 years, and the 10 warmest years on record have all occurred since 2010.
- Atmospheric C0₂ has risen from 364ppm to 427ppm in the last 20 years.
- Current policies will cause global warming of 3.1C or higher over the course of the century.
- Earth has warmed by 1.2°C since pre-industrial times.
- This is hotter than it has been in at least the last 1,000 years.

- Cyclone Gabrielle cost Waikato District Council \$18 million in roading repairs alone.




