#### **REPORTS**

<u>Three Waters Governance Report - May 2024</u> Agenda Item 6.1

Mr Telfer spoke to the report which was taken as read and further discussion was held.

# **Key Highlights:**

- The Te Kauwhata Wastewater Treatment Plant is compliant.
- An incident occurred at the Galbraith Street gravity main project site where a contractor operating an excavator moved the boom into contact with over 11KV overhead powerline.
- Whilst the contact tripped the fuse no harm or damage occurred. The incident was discussed at length by the Board and the health & safety mitigations that are in place were highlighted.

#### **Questions/Discussion:**

 A query was raised in relation to the minimum Personal Protective Equipment (PPE) requirements for Watercare Staff whilst they are onsite. It was noted that these health & safety events appear to be happening on a few occasions so some expectations need to be set and the Board need to have an oversight on what those requirements are.

ACTION: Watercare staff to come back to the Board with the minimum Personal Protective Equipment (PPE) policy requirements for all staff & contractors on all sites when undertaking all works to the next meeting.

 Mr Telfer advised what the new minimum standard PPE requirements are for Watercare staff including safety glasses however it was noted that the Board were looking for absolute specifics in terms of glasses, overalls, safety boots and all other equipment.

- It was queried by the Board when the PPE policy was updated and it was noted that whilst an exact date could be provided it was roughly 3 weeks ago.
- The work of the contractors that were onsite during the incident was acknowledged and the residents close by to the site who lost power were happy with the communications.
- A brief discussion was held in relation to Gate valves vs Ball valves and Mr Telfer explained why Watercare are testing both.
- A query was raised in regards to the Cambrae Road Stormwater project and how
  the team progressing with reviewing the conditions of consent? The consent
  condition states that Council is liable for any impact on private property. It was
  noted that the focus right now is on addressing the abatement notice however
  Watercare will look into this further.
- It was noted in relation to a query around the H2S damage at Taupiri that there was no further examples of damage found.
- It was confirmed that staff are continuing to work with both the property owner and the Council property team to ensure all bases are covered in regards to the Te Akau Water Treatment Plant.
- A query was raised in relation to the Raglan Wastewater Treatment Plant and the
  concept report that has been completed into the land disposal option on the
  Wainui Reserve is there any indication if this option is feasible? It was noted that
  there are still further options being investigated and looked at for disposal options
  so cannot confirm feasibility at this stage.
- It was further noted that staff will start presenting the options to key stakeholders
  this month and it was confirmed that options were also presented at the last
  engagement meeting with the community so communications with the public are
  ongoing.

**ACTION:** Watercare to provide an update to the Board on the Raglan Wastewater Treatment Plant Consent Discharge Options at the June or July meeting.

• A query was raised in relation to how many asbuilts & projects are outstanding across the network? It was noted that an answer cannot be provided at this stage but will be included in all future reporting.

**ACTION:** Watercare to include in the Govenance Report moving forward an overview of the various projects & current works against the outstanding asbuilts.
