2025 LOCAL GOVERNMENT ELECTIONS 11 OCTOBER 2025



→ WHAT DOES COUNCIL DO?

The Waikato District Council meets regularly to make many decisions that impact the day-to-day lives of people in the district. The Council governs a wide range of local services including roads, water systems, rubbish collection, libraries, parks, community centres, dog registration, community and economic development and city planning.

→ BACKGROUND

Local government triennial elections are being held by postal vote on Saturday 11 October 2025 and will be undertaken by Election Services, under contract to the Waikato District Council.

The first past the post (FPP) electoral system will be used for the Waikato District Council, the Te Kauwhata Licensing Trust and the Waikato Regional Council elections.

→ WHO IS BEING ELECTED?

Elections will be required for the following positions:

- → Mayor (elected 'at large')
- \rightarrow Councillors (13)
 - Awaroa-Maramarua General Ward (1)
 - Huntly General Ward (1)
 - Newcastle-Ngaaruawaahia General Ward (2)
 - Tamahere-Woodlands General Ward (2)
 - Tai Raro Takiwaa Maaori Ward (1)
 - Tai Runga Takiwaa Maaori Ward (1)
 - Tuakau-Pookeno General Ward (2)
 - Waerenga-Whitikahu General Ward (1)
 - Western Districts General Ward (1)
 - Whaaingaroa General Ward (1)
- → Community Board Members (32)
 - Huntly Community Board (6)
 - Ngaaruawaahia Community Board (6)

- Rural-Port Waikato Community Board (4) made up of:
 - North Subdivision (2), and
 - South Subdivision (2)
 - Raglan Community Board (6)
- Taupiri Community Board (4)
- Tuakau Community Board (6)
- → Te Kauwhata Licensing Trust (6 members elected 'at large')
- → Waikato Regional Council members
 - Waikato General Constituency, (2), or
 - Ngā Hau e Whā Māori Constituency (1).

In addition, electors of the Waikato District Council area will be able to vote on a poll — whether to retain or disestablish the Maaori wards for the Waikato District Council. The outcome of the binding poll will apply to the 2028 and 2031 triennial elections.

→ HOW CAN I BE NOMINATED?

Nominations for these positions open on Friday 4 July 2025 and close at noon on Friday 1 August 2025.

To be eligible to stand for election, a candidate **must** be:

- → a New Zealand citizen (by birth or naturalisation ceremony); and
- → enrolled as a Parliamentary elector (anywhere in New Zealand); and
- nominated by two electors whose names appear on the electoral roll within the respective area that a candidate is standing for.

A candidate information handbook will be available in May 2025.

→ WHO CAN VOTE?

Those eligible to vote are all resident electors and non-resident ratepayer electors on the electoral roll. The Preliminary Electoral Roll will be available for public inspection between Friday 4 July 2025 and Friday 1 August 2025 at the locations listed above.

Resident Roll: All parliamentary electors, including those on the Maaori Electoral Roll, are automatically enrolled on the Resident Roll, at the address where they live.

Any alterations to the Resident Roll (e.g. change of address details, including new postal addresses) should be made by:



Ratepayer Roll: If a person is on the parliamentary roll in one area and pays rates on a property in another area, this person may be eligible to be enrolled on the non-resident ratepayer roll. A firm, company, corporation or society paying rates on a property may nominate one of its members or officers as a ratepayer elector (provided the nominated person resides outside the area).

All electors will be able to vote for the mayor and respective community board members (if applicable). Those electors on the general electoral roll will be able to vote for the respective general ward councillors and those on the Maaori electoral roll will be able to vote for the respective Maaori ward councillors.



→ HOW TO VOTE?

Voting packs will be posted to all those who have enrolled from Tuesday 9 September 2025.

The voting period is just over four weeks (Tuesday 9 September 2025 to noon Saturday 11 October 2025.)

Electors may post their completed voting documents back to the electoral officer using the orange replypaid envelope sent with their voting document.

Polling places for the issuing of special voting documents and for the receiving of completed voting documents will be available from Tuesday 9 September 2025 to noon Saturday 11 October 2025 at the following locations:


In addition, votes can also be hand delivered to a vote box at specific locations found on Council's website: www.waikatodistrict.govt.nz/elections

To be counted, all completed voting documents must be in the hands of the electoral officer or an electoral official by noon, Saturday 11 October 2025.

→ RESULTS

Progress results will be known early afternoon on election day, and preliminary results will be known on Sunday 12 October 2025.
