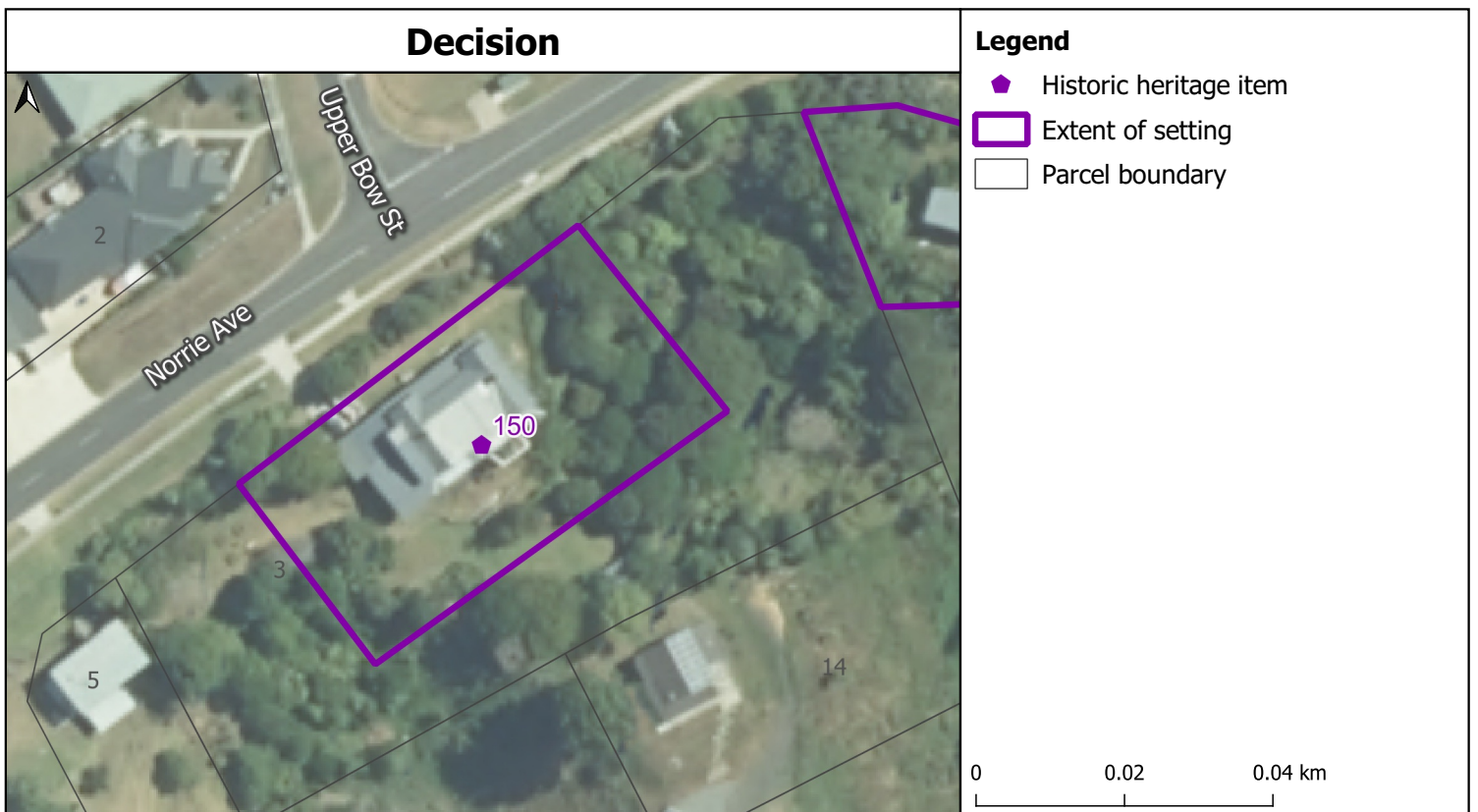
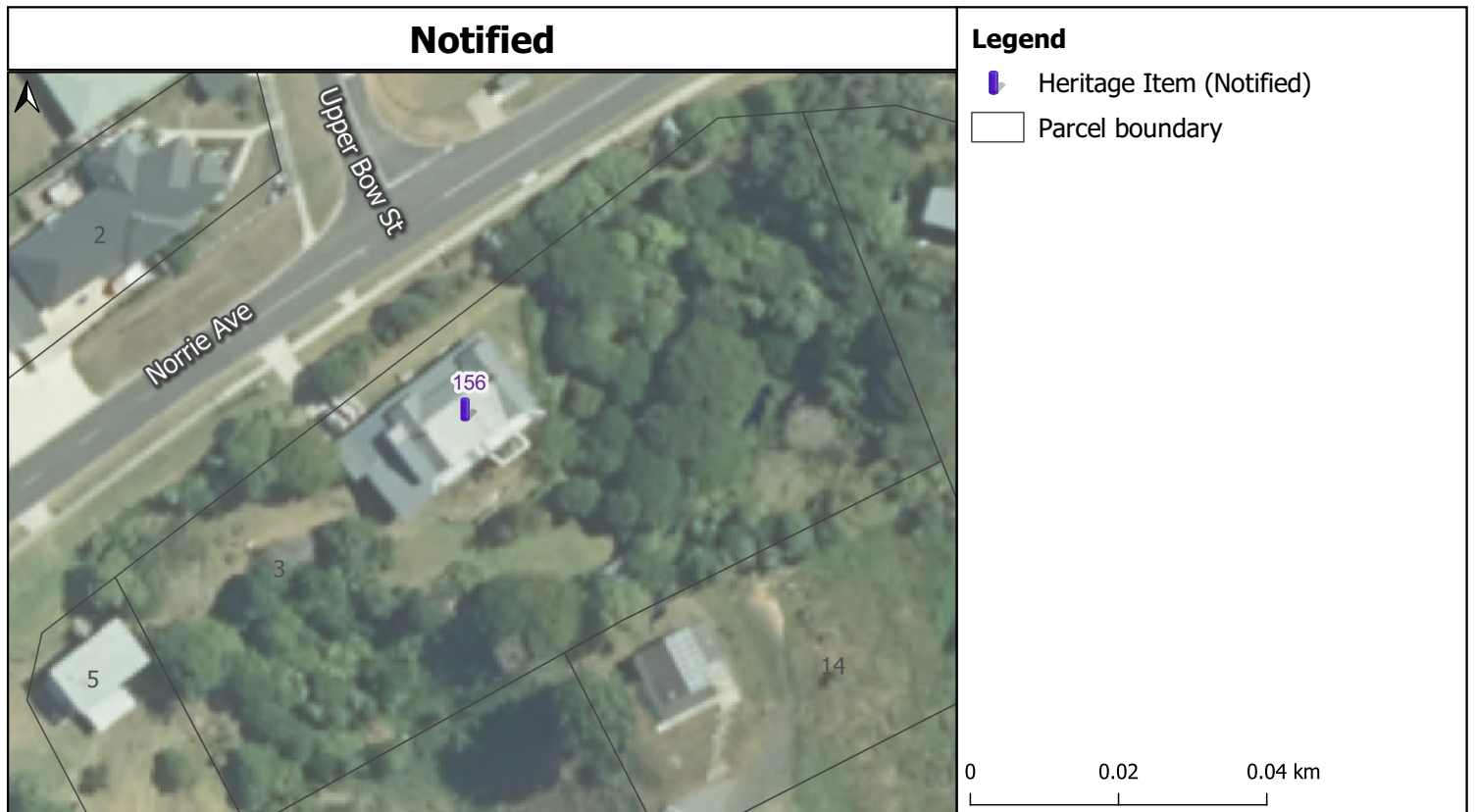


Former Maunder Residence (c.1900) 1 Main Road, Raglan

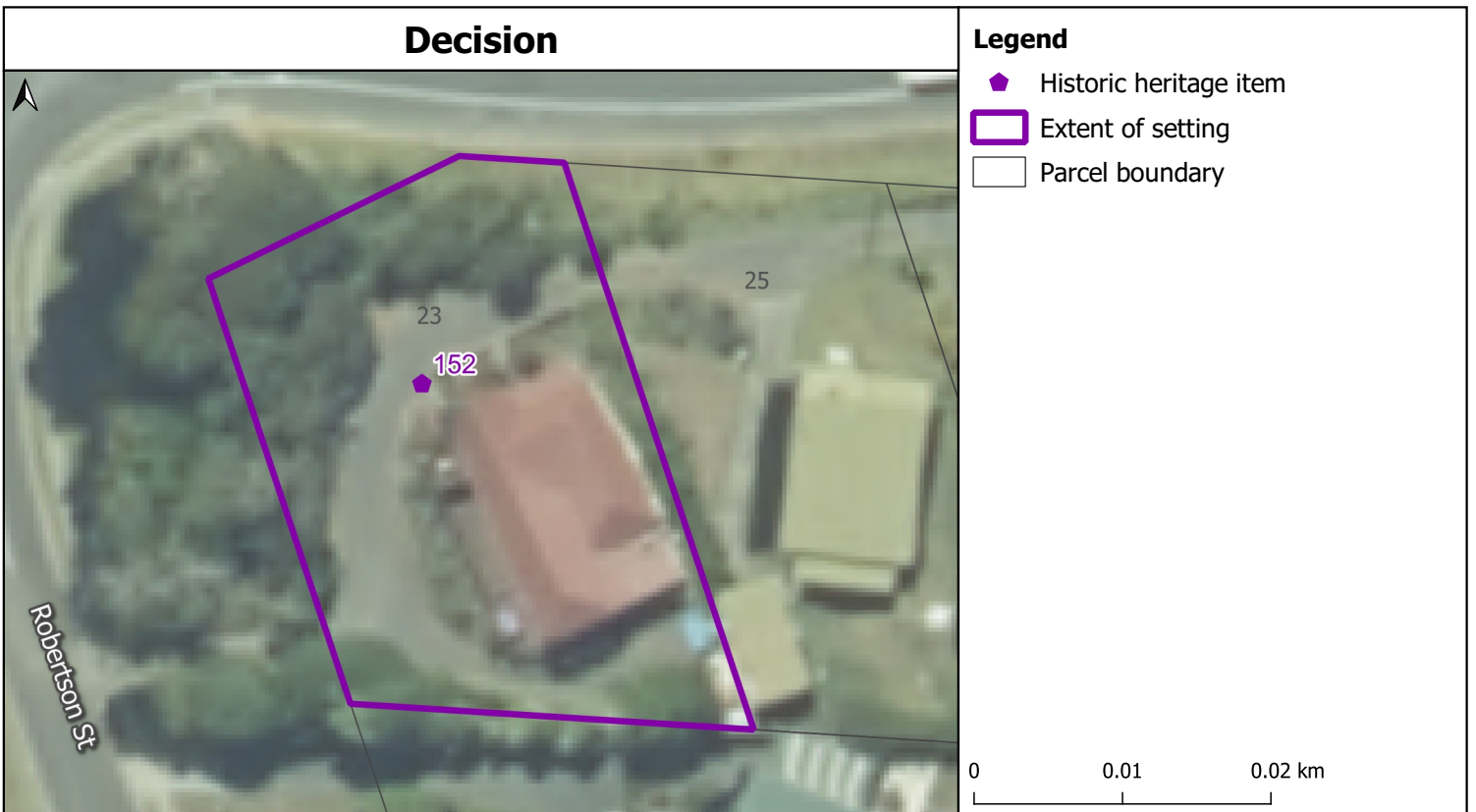
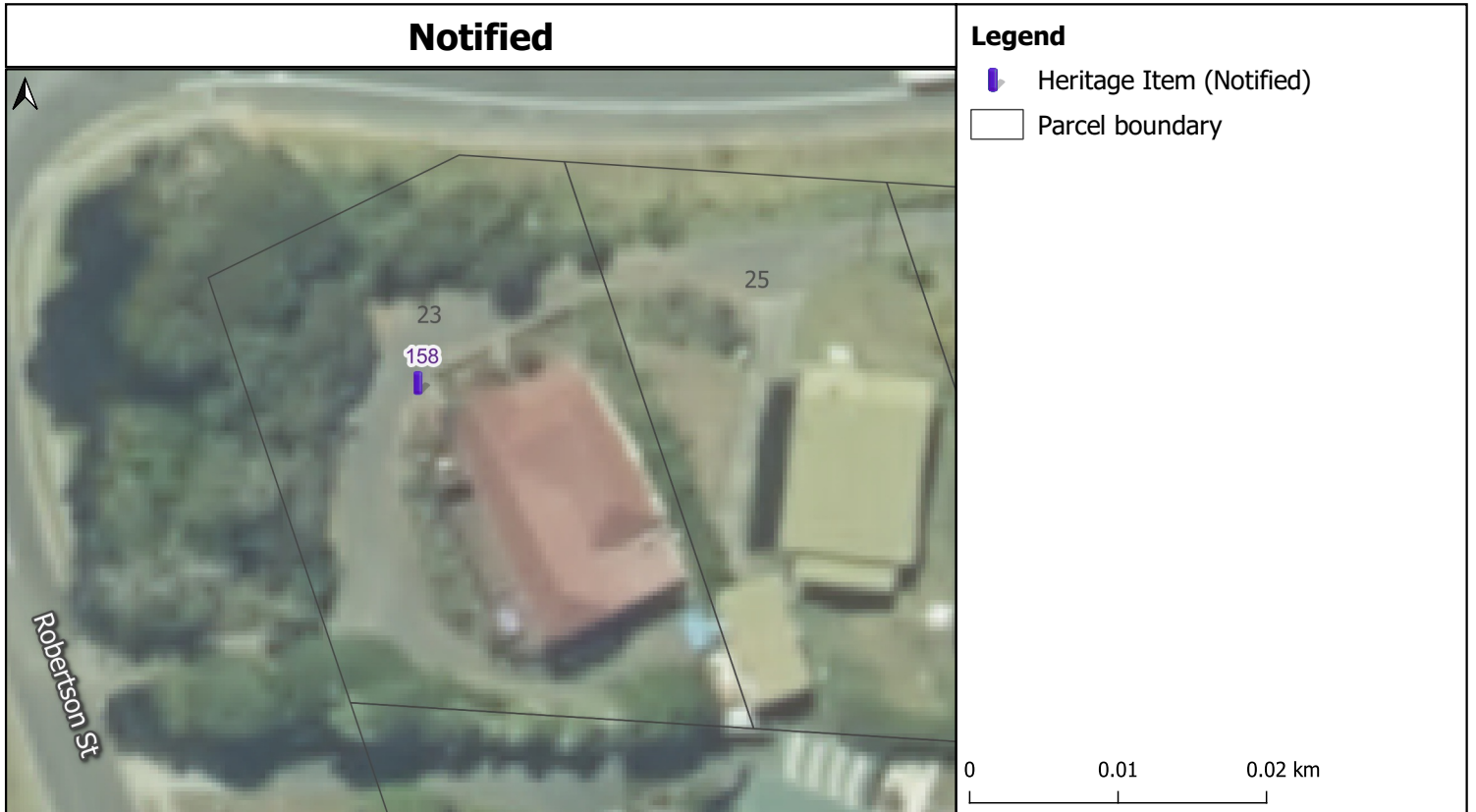


Wiremu Te Awaitaia Monument (1870) Te Kopua Domain, Marine Parade, Raglan
